A RESOLUTION BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE AUTHORIZING THE SETTLEMENT OF ALL CLAIMS AGAINST DEFENDANT IN THE CASE OF TAMMY GLAZE V. ATLANTA POLICE DEPARTMENT, IN THE AMOUNT OF \$67,500.00 (THE "SETTLEMENT AMOUNT"); AUTHORIZING THE SETTLEMENT AMOUNT TO BE CHARGED TO AND PAID FROM FUND 1001 (GENERAL FUND), CENTER NUMBER 200101 (NON-DEPARTMENTAL), ACCOUNT 5212005 (LITIGATION EXPENSES) AND FUNCTIONAL ACTIVITY NUMBER 151200 (ACCOUNTING) AUTHORIZING THE CHIEF FINANCIAL OFFICER TO DISTRIBUTE THE SETTLEMENT AMOUNT; AND FOR OTHER PURPOSES.

WHEREAS, former APD employee Tammy Glaze retained counsel submitted an Ante Litem Notice of Tort Claims, alleging that she was subjected to retaliation, discriminatory treatment and wrongfully terminated on April 12, 2019; and

WHEREAS, Charging Party has agreed to accept the total amount of \$67,500.00 in full settlement of all claims against City of Atlanta; and

WHEREAS, the City Attorney considers it to be in the best interest of the City of Atlanta to pay the Settlement Amount to settle all claims against the City of Atlanta; and

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, hereby resolves as follows:

SECTION 1. The City Attorney is hereby authorized to settle and execute all documents in the case of *Tammy Glaze v. Atlanta Police Department*, in the amount of Sixty-Seven Thousand, Five Hundred Dollars and Zero Cents (\$67,500.00).

SECTION 2. The Chief Financial Officer is authorized to make payment from Fund 1001 (General Fund), Center Number 200101 (Non-Departmental), (Account 5212005) (Litigation Expenses) and Functional Activity Number 1512000 (Accounting). Payment shall be in the form of two checks in the combined total amount of \$67,500.00 (Check No. 1 in the amount of \$43,875.00 payable to Golden & Malachi, LLC (for Tammy Glaze) 1050 Spring Street, NW, Atlanta, Georgia 30309 and Check No. 2 in the amount of \$23,625.00 payable to Golden & Malachi, LLC 1050 Spring Street, NW, Atlanta, GA 30309. Such payment shall be in full consideration of the dismissal of all claims against the City of Atlanta.


